### I. REGISTRATION OF FISHING VESSEL THREE (3) GROSS TONNAGE AND BELOW

**ABOUT THE SERVICE:** Based on City Ordinance No. 618, November 21, 2012.

**Section 10. Licensing of Fishing Boats Three (3)**

**Gross tons or less-** No persons shall be allowed to operate fishing boats three (3) gross tons or less without the fishing boat license issued by the Mayor. Fishing boat license shall only be issued to registered fishing vessels in accordance with the City Ordinance No. 445-2007.

**Section 11. Requirements for license and Permits.**

An Applicant for a license permit shall comply with the following requirements to issue of the same.

#### REQUIREMENTS:

1. Duly Notarized MFVR Application Form 1
2. MFVR Certificate of admeasurement Form 2
3. Two (2) Size (4"x 6) Picture of the boat (one shot side view, full length And one perspective shot with applicant on the side.)  
See Photo.
4. Barangay Certificate of Ownership
5. PNP – MARICOM Clearance.
6. Payment of appropriate fee's (Registration Fee and Inspection Fee)

#### APPROPRIATE FEES AND CHARGES

- Non - Motorized Vessel - Php. 50.00
- Motorized Vessel – 10HP and less than 15HP - Php. 200.00
- Motorized Vessel – 11HP and less than 15HP - Php. 300.00
- Motorized Vessel – 15HP but less than 50HP - Php. 500.00

- Motorized Vessel – 50HP and UP

- Php. 1,000.00
