CITY ORDINANCE NO. 968

AN ORDINANCE ALLOWING THE USE OF THE SIDEWALK ALONG PUBLIC PLAZA FOR THE USE OF THE CITY AS AN AREA FOR A TRADE FAIR FOR THE PERIOD FROM NOVEMBER 1, 2021 TO DECEMBER 31, 2021, AND FOR THE CITY MAYOR'S OFFICE TO IDENTIFY THE BENEFICIARIES OF THIS PROJECT IN ACCORDANCE TO SUCH RULES AS MAY BE SET THEREFOR BY SAID OFFICE AND LIKEWISE SET AN AMOUNT FOR THE LEASE OF ANY PORTION OF SUCH AREA FROM THE BENEFICIARIES.

Be it ordained by the Sangguniang Panlungsod of Bacolod, in session assembled, that;

**Section 1-** The use of the sidewalk along public plaza for the use of the City as an area for a Trade Fair is hereby allowed for the period from November 1, 2021 to December 31, 2021, and for the City Mayor's Office to identify the beneficiaries of this project in accordance to such rules as may be set therefor by said office and likewise set an amount for the lease of any portion of such area from the beneficiaries.


**Section 2-** This ordinance shall take effect upon its approval.






