## CITY ORDINANCE NO. 984 FEBRUARY 09, 2022

AN ORDINANCE AMENDING SECTION 4 OF CITY ORDINANCE NO. 08-15-758 SERIES OF 2015, ALSO KNOWN AS "AN ORDINANCE DECLARING THE BACOLOD-JAPAN FRIENDSHIP DAY AS AN ANNUAL CELEBRATION IN THE CITY OF BACOLOD",

**WHEREAS**, City Ordinance No. 08-1 5-758 was passed last September 23, 2015 to strengthen the long standing friendship between Bacolodnons and Japanese through exchanges of cultural knowledge and traditions;

**WHEREAS,** currently the Bacolod-Japan Friendship Day falls on the major Japanese festival which is similar to the Philippines' All Souls Day holiday wherein people are reuniting to celebrate the departed;

**WHEREAS,** the Japanese community in Bacolod City calls for the change of date of the said Friendship Day be celebrated;

WHEREAS, the Bacolod City Government aims to move the celebration of the Bacolod Japan friendship Day to mid-March to mid-April to commemorate the Sakura Matsuri Festival which is also one of the major Japanese festivals where most of the Japanese tourists travel to other places;

Now therefore, be it ordained as it is hereby ordained by the Sangguniang Panlungsod in session assembled, that:

**SECTION** 1. Section 4 of City Ordinance 08-15-758 Series of 2015 which reads:

SECTION 4. BACOLOD-JAPAN FRIENDSHIP DAY AN ANNUAL CELEBRATION.

The Bacolod-Japan Friendship Day celebration is henceforth made an annual celebration in the City of Bacolod.

The celebration shall be celebrated between mid-July and mid-August in Bacolod City to coincide with the Obon Matsuri (Japanese Lantern Festival) celebrated in mid-July and mid-August of every year.

## SECTION 4. BACOLOD-JAPAN FRIENDSHIP DAY AN ANNUAL CELEBRATION.

The Bacolod-Japan Friendship Day is henceforth made an annual tourism event in the City of Bacolod to be celebrated between mid-March to mid-April of every year to commemorate the Sakura Matsuri (Japanese Cherry Blossom Festival).
