SOCIO-ECONOMIC PROFILE

A Socio- Economic Profile is a document that describes the present and actual situation of a community in relation to its natural and human resources of the Local Government Unit. It also includes its historical background, physical features, public services and existing land uses. Data and information are analyzed to facilities easy access to information by planners in the formulation of local development plan.

The purpose of this profile will greatly aid the planning body of the barangay in the identification of its needs and problems. Added to this, prioritization of projects relative to the use of resources and its significance to its barangay residents will also be address.

I. HISTORICAL BACKGROUND

Barangay 37 was officially created in January 5, 1973 into a barangay by virtue of Presidential Decree No. 86 and 86-A stating that all barrios and poblacion in the Philippines will be changed into barangays. Pursuant to Republic Act 3590.

As amended by P.D. 86 and 86-A powers vested in the barrios shall hence forth be exercised by strengthening and defining the role of the barangay. P.D. 86-A provides that the collective views of the people shall be considered in the formation of national policies and programs.

In the year 1973, Honorable City Mayor CARLOS BENARES requested an emergency citizens assembly purposely to appoint the corresponding Barangay Officials through public nomination. MRS. MILDRED G. ONG had been appointed Barangay Captain. The result of such election of Barangay Officials is in accordance with the votes garnered are as follows to wit;
