RESOLUTION RESPECFULLY REQUESTING MISS FARAH JENNY MONTECLARO BRANCH MANAGER BACIWA-PRIMEWATER THROUGH MONA DIA JARDIN GENERAL MANAGER BACIWA-PRIMEWATER INFRASTRUCTURE CORPORATION TO PROVIDE THE SANGGUNIANG PANLUNGSOD OF BACOLOD CITY A WRITTEN EXPLANATION AS TO THEIR REPORTEDLY POOR WATER SERVICES.

Upon motion of Councilor Claudio Jesus Raymundo A. Puentevella, jointly seconded by Councilors Simplicia Z. Distrito, Jude Thaddeus A. Sayson, Renecito S. Novero and Jason Isidro S. Villarosa, amended by Councilor Renecito S. Novero, the Sangguniang Panlungsod of Bacolod

RESOLVED, to pass the following resolution:

WHEREAS, Section 9 of Article XVI of the 1987 Philippine Constitution provides that the State shall protect consumers from trade malpractices and from substandard or hazardous products;



WHEREAS, the Bacolod City Water District (BACIWA) is considered to be a Government-owned and controlled corporation, the same is imbued with the public interest and its creation or charter emanated from Presidential Decree 198;

WHEREAS, the Joint Venture Agreement (JVA) entered into by BACIWA and Primewater Infrastructure Corp. (Primewater) aims to provide potable, reliable, and sustainable water supply and services to its consumers in the city;

WHEREAS, it has come to the attention of the members of the Sangguniang Panlungsod that numerous resident-consumers of Bacolod City are complaining of the services being provided by BACIWA- PRIMEWATER that the water is tainted with color, mud, and sand particles and the unpredictable availability of water supply in some areas of Bacolod City.

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to respectfully request Miss Farah Jenny Monteclaro Branch Manager BACIWA-Primewater through Mona Dia Jardin General Manager BACIWA-Primewater Infrastructure Corporation to provide the Sangguniang Panlungsod of Bacolod City a written explanation as to their reportedly poor water services.
