

RESOLUTION ADOPTING THE RECOMMENDATIONS SUBMITTED BY POLICE COLONEL THOMAS JOSEPH I. MARTIR, CITY DIRECTOR, BACOLOD CITY POLICE OFFICE, AS THE “DONTS” TO BE OBSERVED BY THE FESTIVAL GOERS AT THE FESTIVAL SITES FOR THE DURATION OF THE 43RD MASSKARA FESTIVAL ON OCTOBER 1 - 23, 2022, DOCKETED AS SP CORRESPONDENCE NO. 14-22-0382 AND LIKEWISE REFERRING THE SAME TO THE BACOLOD YUHUM FOUNDATION, THRU THE OFFICE OF THE HONORABLE CITY MAYOR ALFREDO ABELARDO B. BENITEZ.

Upon motion of Councilor Psyche Marie E. Sy, jointly seconded by Councilors Celia Matea R. Flor, Claudio Jesus Raymundo A. Puentevella and Floor Leader Al Victor A., Espino, the Sangguniang Panlungsod of Bacolod

RESOLVED, to adopt the recommendations submitted by Police Colonel Thomas Joseph I. Martir, City Director, Bacolod City Police Office, as the “Donts” to be observed by the festival goers at the festival sites for the duration of the 43rd Masskara Festival on October 1 - 23, 2022, to wit:

1. Carrying of glass/can bottled liquors/softdrinks while walking inside festival site;
2. Carrying of firearms, other deadly weapon to include pointed barbeque stick;



3. No smoking (except in the designated areas);
4. Flying of drone (except authorized by the Yuhum Foundation and the PNP);
5. Lighting of firecrackers and similar pyrotechnics;
6. Carrying knapsack inside the festival area; and
7. Prank jokes that will cause stampede.
