WHEREAS, on November 26, 2018, the then Sangguniang Panlungsod members passed City Ordinance No. 868;

WHEREAS, Section 3 of the said Ordinance is hereby refurnished, to wit:

“Section 3. OBJECTIVES. This Ordinance has the following objectives:



1. To promote the spirit of Christmas.
2. To keep and maintain certain traditions and values which are historical and cultural importance”;

WHEREAS, Section 5 is also refurnished, to wit:

“Section 5. CREATION OF COMMITTEE. In implementing the intents of this Ordinance there shall be created a Christmas Festival of Lights Committee (CFLC), the composition of which shall be as follows:
