RESOLUTION RESPECTFULLY URGING THE BACOLOD TRAFFIC AUTHORITY OFFICE, THROUGH MAJOR JUNJI LIBA, TO DEPLOY TRAFFIC ENFORCERS, INSTALL ROAD SIGNAGES, SAFETY DEVICES AND BARRIERS TO PREVENT PEDESTRIANS FROM JAYWALKING ALONG THE LACSON-CIRCUMFERENTIAL FLYOVER AT BARANGAY BATA TO PREVENT ROAD ACCIDENTS.

Upon motion of Councilor Claudio Jesus Raymundo A. Puentevella, jointly seconded by Councilors Celia Matea R. Flor, Cindy T. Rojas and Em L. Ang, the Sangguniang Panlungsod of Bacolod

RESOLVED, to pass the following resolution:

WHEREAS, Section 5 of Article II of the 1987 Philippine Constitution provides that the maintenance of peace and order, the protection of life, liberty, and property, and promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy;

WHEREAS, Republic Act No. 7160 or otherwise known as the Local Government Code of 1991 provides that the Local Government Units shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Numerous fatal road accidents involving pedestrian and motorist occur along the Lacson-Circumferential Flyover;

WHEREAS, the deployment of additional traffic enforcers will ensure the enforcement of traffic laws around the Lacson-Circumferential Flyover;

WHEREAS, the installation of road signages and barriers will prevent pedestrians to jaywalk along the Lacson-Circumferential Flyover and to use the designated pedestrian lane provided.

NOW THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to respectfully urge the Bacolod Traffic Authority Office, through Major Junji Liba, to deploy Traffic Enforcers, install road signages, safety devices and barriers to prevent pedestrians from jaywalking along the Lacson-Circumferential flyover at Barangay Bata to prevent road accidents.
