RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ALFREDO ABELARDO B. BENITEZ TO SIGN THE PROPOSED CONTRACT OF LEASE ENTERED INTO BY AND BETWEEN THE CITY OF BACOLOD AND MR. DANTE R.
