**RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ALFREDO ABELARDO B. BENITEZ TO SIGN ALL REQUIRED DOCUMENTS RELATIVE TO THE REQUEST FOR FULL REIMBURSEMENT WITH THE CAP OF TEN MILLION PESOS (PHP10,000,000.00) ON THE INTEREST SUBSIDY FUND (ISF) OF THE TERM LOAN OBTAINED BY THE CITY GOVERNMENT OF BACOLOD WITH THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP) ON THE ENROLLMENT/RETAGGING OF BACOLOD CITY LOAN ACCOUNT WITH 2% P.A. 
