**RESOLUTION NO. 768

**RESOLUTION URGING THE BACOLOD TRAFFIC AUTHORITY OFFICE (BTAO), THROUGH THE OFFICE OF THE CITY MAYOR, TO SUBMIT TO THE SANGGUNIANG PANLUNGSOD EVERY 15<sup>TH</sup> OF THE MONTH STARTING OCTOBER 15, 2022, MONTHLY TRAFFIC PLANS, STRATEGIES, POLICIES, PROGRAMS, AND REPORTS PERTAINING TO THE TRAFFIC MANAGEMENT IN THE CITY OF BACOLOD INCLUDING PROGRAMS AND TRAININGS CONDUCTED BY ITS TRAFFIC ENFORCERS.**

Upon motion of Floor Leader Al Victor A. Espino, jointly seconded by Councilors Celia Matea R. Flor and Simplicia Z. Distrito, the Sangguniang Panlungsod of Bacolod

**RESOLVED**, to pass the following resolution:

**WHEREAS**, pursuant to City Ordinance No. 315 "AN ORDINANCE ORGANIZING THE BACOLOD TRAFFIC AUTHORITY OFFICE (BTAO), SUBJECT TO CITY ORDINANCE NO. 230", wherein the following are the duties and responsibilities of Traffic Operations Officer IV and/or acting BTAO HEAD, to wit:

1. Planning, monitoring, coordinating and evaluating the plans and implementation of the City Government and line agencies;




2. Translates policies into operational goals and specific objectives consistent with available resources;
3. Regulates the utilization of various roads based on existing City Ordinances;
4. Instructs and conducts practical training of its staff;
5. Maintains personnel discipline in the office and undertakes to acquire familiarity with organizations, operations and financial activities of the office;
6. Assists in drafting programs of instruction that will be necessary for the enhancement of the working capability of the traffic enforcers;
7. Assists in conducting information, dissemination for the public to be aware of the programs implemented by the City relative to traffic;
8. Evaluates trainings conducted and offers suggestions for improvement;
9. Conducts research needed in the preparation of the programs of training;
10. Prepare schedule in training calendar for the proposed training;
11. Conducts studies that are deemed necessary for the education and training of personnel;
12. And close related work.

**WHEREAS**, the Sanggunian Body must be apprised of all the plans, strategies, policies and projects of the Bacolod Traffic Authority Office to improve the traffic conditions in the City of Bacolod;

**WHEREAS**, the Sanggunian Body, up to date, were not duly informed by the acting BTAO Head of any plans, improvements, strategies and projects relating to traffic regulations and management;

**WHEREAS**, it is imperative for the Bacolod Traffic Authority Office (BTAO) to submit the necessary monthly reportorial requirements to improve the traffic flow in the City of Bacolod;

**WHEREAS**, to manage and improve the traffic conditions in the City of Bacolod, the Sanggunian shall review the submitted monthly reportorial requirements and shall assess and review therein, and further submit its recommendations and suggestions for the betterment of the traffic flow in the City of Bacolod;



**NOW THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, to urge the Bacolod Traffic Authority Office (BTAO), through the Office of the City Mayor, to submit to the Sanggunian Panlungsod every 15<sup>th</sup> of the month starting October 15, 2022, monthly traffic plans, strategies, policies, programs, and reports pertaining to the traffic management in the City of Bacolod including programs and trainings conducted by its traffic enforcers.


