

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ALFREDO ABELARDO B. BENITEZ TO SIGN THE PROPOSED MEMORANDA OF AGREEMENT ENTERED INTO BY AND BETWEEN THE CITY OF BACOLOD AND BARANGAYS 7, 12, 14, 22, 26, 27, 31, 34, 35, ALANGILAN, ALIJIS, GRANADA, SINGCANG-AIRPORT AND SUM-AG, REPRESENTED BY THEIR RESPECTIVE PUNONG BARANGAYS, RE: FINANCIAL ASSISTANCE IN THE AMOUNT OF TWO HUNDRED THOUSAND PESOS (PHP200,000.00) FOR EACH BARANGAY FOR THE MASSKARA FESTIVAL STREET DANCE, DOCKETED AS SP CORRESPONDENCE NO. 11-22-0440.
