RESOLUTION RESPECTFULLY URGING THE HONORABLE CITY MAYOR ALFREDO ABELARDO BANTUG BENITEZ, TO STRONGLY CONSIDER IMPROVING, RENOVATING AND UPGRADING THE FACILITIES OF THE BACOLOD CITY MENTAL HEALTH CARE CENTER LOCATED AT BARANGAY MANSILINGAN, BACOLOD CITY.

Upon motion of Councilor Israel P. Salanga, jointly seconded by Councilors Jason Isidro S. Villarosa, Claudio Jesus Raymundo A. Puentevella, Em L. Ang, Cindy T. Rojas and Simplicia Z. Distrito, the Sangguniang Panlungsod of Bacolod

RESOLVED, to pass the following resolution:

WHEREAS, by virtue of Ordinance No. 375 "AN ORDINANCE ESTABLISHING A BACOLOD CITY MENTAL HEALTH CARE CENTER UNDER THE CITY HEALTH OFFICE AND PROVIDING FUNDS THEREFOR", the Bacolod City Mental Health Care Center located at Barangay Mansilingan was constructed;

WHEREAS, the general objectives of the abovementioned ordinance is to consult, admit and treat mentally ill patients in Out-Patient Department (OPD) and In-Patient Department, facilitate the detoxification and treatment of psychotic substance abusers, de-institutionalize patients and -reintegrate them to their family and community, and to take care of the chronically;



WHEREAS, the Bacolod City Mental Health Care Center has been providing assistance to patients with mental health disorders from Bacolod City since 2004 and there is a growing need to improve, renovate and upgrade its facilities to treat and accommodate more patients;

WHEREAS, problems arising from mental health disorders wherein people who suffers from the said disorder are roaming around the city causing hazard not only to themselves but as well as to the general public must be addressed by diagnosing and treating them in a proper mental health facility;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to respectfully urge the Honorable City Mayor Alfredo Abelardo Bantug Benitez, to strongly consider improving, renovating and upgrading the facilities of the Bacolod City Mental Health Care Center located at Barangay Mansilingan, Bacolod City.


