RESOLUTION RESPECTFULLY URGING THE HONORABLE CITY MAYOR ALFREDO ABELARDO BANTUG BENITEZ, TO CONVENE THE MENTAL HEALTH WEEK COMMITTEE AND TO PLAN THE CONDUCT OF A MASSIVE AWARENESS CAMPAIGN ON PROMOTING MENTAL HEALTH AS WELL AS THE PREVENTION AND TREATMENT OF MENTAL HEALTH DISORDERS IN COORDINATION WITH ALL THE BARANGAYS OF BACOLOD CITY FOR THE UPCOMING MENTAL HEALTH DAY ON OCTOBER 10 AS PER ORDINANCE NO. 08-14-0674, SERIES OF 2014.

Upon motion of Councilor Israel P. Salanga, jointly seconded by Councilors Cindy T. Rojas, Em L. Ang, Jason Isidro S. Villarosa and Simplicia Z. Distrito, the Sangguniang Panlungsod of Bacolod

RESOLVED, to pass the following resolution:

WHEREAS, City Ordinance No. 08-14-674 entitled "AN ORDINANCE DECLARING OCTOBER 10 OF EVERY YEAR AS THE MENTAL HEALTH DAY IN THE CITY OF BACOLOD, PROVIDING FUNDS THEREOF AND FOR OTHER PURPOSES" was approved by the Sangguniang Panlungsod of Bacolod City on June 2, 2014 and was approved by the city mayor on June 13, 2014;



WHEREAS, by virtue of the abovementioned ordinance, a Mental Health Week Committee was created which is tasked to supervise and take charge of the implementation of the said ordinance;

WHEREAS, the World Health Organization (WHO) celebrates October 10 as the Mental Health Day, the objective of which is to raise awareness of mental health issues around the world and to mobilize efforts in support of mental health;

WHEREAS, the Mental Health Day on October 10 is fast approaching and there is a need to plan out activities in celebration of the said event;

WHEREAS, problems arising from mental health disorders wherein people who suffers from the said disorder are roaming around the city causing hazard not only to themselves but as well as to the general public must be addressed by raising awareness on how to prevent and treat these mental disorders as well as the promotion of overall mental health of each individual;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to respectfully urge the Honorable City Mayor Alfredo Abelardo Bantug Benitez, to convene the Mental Health Week Committee and to plan the conduct of a massive awareness campaign on promoting mental health as well as the prevention and treatment of mental health disorders in coordination with all the barangays of Bacolod City for the upcoming Mental Health Day on October 10 as per Ordinance No. 08-14-0674, Series of 2014.


