**RESOLUTION REFERRING TO THE OFFICE OF THE CITY MAYOR THE PROPOSED RESOLUTION AUTHORED BY COUNCILOR CELIA MATEA R. FLOR, ENTITLED: "RESOLUTION FOR TEMPORARY CLOSURE OF ONE LANE ALONG BONIFACIO STREET TO SERVE AS VENDING AREA FOR FISH AND VEGETABLE VENDORS PENDING COMPLETING OF REPAIRS OF THE FISH AND VEGETABLE SECTION AT CENTRAL MARKET", FOR APPROPRIATE ACTION.**

Upon motion of Councilor Celia Matea R. Flor, seconded by Councilor Renecito S. Novero, the Sangguniang Panlungsod of Bacolod

**RESOLVED**, to pass the following resolution:

**WHEREAS**, there is an ongoing construction at Central Market for its rehabilitation and improvement;

**WHEREAS**, vendors affected by the construction were temporarily transferred along Gatuslao and Luzuriaga St.;

**WHEREAS**, the current situation hinders the flow of traffic along aforementioned streets as they are high-traffic and busy;

**WHEREAS**, there is a need to relocate the affected vendors whilst also considering the situation of traffic in the area;

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED**, to refer to the Office of the City Mayor the proposed resolution authored by Councilor Celia Matea R. Flor, entitled: "Resolution for temporary closure of one lane along Bonifacio Street to serve as vending area for fish and vegetable vendors pending completing of repairs of the Fish and Vegetable Section at Central Market", for appropriate action.


