
RESOLUTION URGENTLY REQUESTING THE BACOLOD CITY POLICE, THROUGH CITY DIRECTOR THOMAS JOSEPH MARTIR, TO INTENSIFY THE ENFORCEMENT OF REPUBLIC ACT NO. 9165 OR OTHERWISE KNOWN AS "THE COMPREHENSIVE DANGEROUS DRUGS ACT OF 2002", TO PREVENT THE SALE, USE AND DISTRIBUTION OF PARTY DRUGS AND OTHER IILEGAL CONTRABAND DURING THE CELEBRATION OF MASSKARA FESTIVAL IN THE CITY OF BACOLOD.

Upon motion of Councilor Claudio Jesus Raymundo A. Puentevella, jointly seconded by Councilors Celia Matea R. Flor, Simplicia Z. Distrito and Israel P. Salanga, the Sangguniang Panlungsod of Bacolod

RESOLVED, to pass the following resolution:

WHEREAS, Section 5 of Article II of the 1987 Philippine Constitution provides that the maintenance of peace and order, the protection of life, liberty, and property, and the promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy.

WHEREAS, Section 15, Article II of the 1987 Constitution mandates the protection and promotion of the right to health of the people and instill health consciousness among them;



WHEREAS, Section 2 of Republic Act No. 9165 or otherwise known as the “Comprehensive Dangerous Drugs Act of 2002”, provides that it is the policy of the State to safeguard the integrity of its territory and the well-being of its citizenry particularly the youth, from the harmful effects of dangerous drugs on their physical and mental well-being, and to defend the same against acts or omissions detrimental to their development and preservation. In view of the foregoing, the State needs to enhance further the efficacy of the law against dangerous drugs, it being one of today's more serious social ills.

WHEREAS, Republic Act No. 7160 or otherwise known as the Local Government Code of 1991 provides that the Local Government Units shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare.

WHEREAS, the upcoming celebration of the Masskara festival in the City of Bacolod would attract hundreds of visitors and tourist which may provide an avenue for drug peddlers to sale and distribute party drug.

WHEREAS, the intensified enforcement of the Comprehensive Dangerous Drugs Act of 2002 will prevent the proliferation of party drugs and other contraband during the celebration of the Masskara festival which is detrimental to the safety and well-being of the youth and the general public.

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to urgently request the Bacolod City Police Office, through City Director Thomas Joseph Martir to intensify the enforcement of Republic Act No. 9165 or otherwise known as “The Comprehensive Dangerous Drugs Act of 2002”, to prevent the sale, use and distribution of party drugs and other illegal contraband during the celebration of Masskara Festival in the City of Bacolod.


Councilor Jason Isidro S. Villarosa was not around when this resolution was passed.
