**RESOLUTION NOMINATING COUNCILOR PSYCHE MARIE E. SY AS MEMBER OF THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB).**


Upon motion of Floor Leader Al Victor A. Espino, jointly seconded by Councilors Claudio Jesus Raymundo A. Puentevella, Simplicia Z. Distrito and Celia Matea R. Flor, the Sangguniang Panlungsod of Bacolod

**RESOLVED**, to pass the following resolution:

**WHEREAS**, the Local Government Code of 1991, pursuant to Section 43 of Republic Act No. 6975, as amended by R.A. 8551 otherwise known as the Philippine National Police Reform and Reorganization Act of 1998 mandates every LGU to establish the People's Law Enforcement Board (PLEB);

**WHEREAS**, the same law establishes PLEB's composition as follows:

1. Any member of the Sangguniang Panlungsod;
2. Any Barangay Captain, who shall be chosen by the Association of Barangay Captains;



3. Three (3) other members who are removable only for cause shall be chosen by the Peace and Order Council from among respected members of the community known for their probity and integrity, one (1) of whom must be a woman, one (1) a member of the Bar, in the absence thereof, a college graduate, or the principal of the central elementary school in the locality;

**WHEREAS**, based on the provisions of R.A. 8551, "the term of office for the member of the PLEB shall be three (3) years from assumption of office, until their successor shall have been chosen and qualified";

**WHEREAS**, the City Peace and Order Council is yet to choose its three (3) representatives for the PLEB;

**WHEREAS**, to complete the membership of the PLEB, there is a need for the Sangguniang Panlungsod of Bacolod City to designate its representative.

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED**, to nominate Councilor Psyche Marie E. Sy, who is presently the Chairperson on Social Defense, Peace and Order, as Member of the People's Law Enforcement Board (PLEB).

**RESOLVED FURTHER**, that copies of this resolution, upon approval, be furnished the People's Law Enforcement Board (PLEB) and the City Peace and Order Council for its necessary action.
