RESOLUTION APPROVING THE REQUEST OF BISHOP PATRICIO A. BUZON, SDB, D.D., DIOCESE OF BACOLOD, REQUESTING TO HOLD A TRADE FAIR ON SOUVENIR ITEMS AND DRY GOODS ON OCTOBER 1, 2022 TO JANUARY 2, 2023 AT THE SIDEWALK OF GATUSLAO STREET ACROSS MERZCI BREAD AND PASTRIES, THE LENGTH OF THE SIDEWALK ALONG RIZAL STREET FRONTING LA CONSOLACION COLLEGE, ALL THE WAY TO QUEEN CITY DEVELOPMENT BANK AND A PORTION OF THE SIDEWALK ALONG SAN JUAN STREET FRONTING BONGBONG'S PASALUBONG CENTER, AND FAVORABLY ENDORSING MR. NIÑO M. CUERPO AS TRADE FAIR ORGANIZER, DOCKETED AS SP CORRESPONDENCE NO. 11-22-0121.


