PINKY MIRANO-OCAMPO, PRESIDENT, BACOLOD YUHUM FOUNDATION, INC., DIRECTOR, MASSKARA FESTIVAL 2022, FOR A TEMPORARY ROAD CLOSURE, BARRICADES, WARNING SIGNS AND TRAFFIC ASSISTANCE DURING THE VARIOUS EVENTS OF MASSKARA FESTIVAL CELEBRATION, DOCKETED AS SP CORRESPONDENCE NO. 11-22-0505, PURSUANT TO THE PROVISIONS OF ARTICLE 45, IMPLEMENTING RULES AND REGULATIONS OF THE LOCAL GOVERNMENT CODE OF THE PHILIPPINES, FOR APPROPRIATE ACTION.

Upon motion of Floor Leader Al Victor A. Espino, jointly seconded by Councilors Celia Matea R. Flor and Cindy T. Rojas, the Sangguniang Panlungsod of Bacolod

RESOLVED, to favorably endorse to the Office of the City Mayor the request of Atty. Pinky Mirano-Ocampo, President, Bacolod Yuhum Foundation, Inc., Director, Masskara Festival 2022, for a temporary road closure, barricades, warning signs and traffic assistance during the various events of Masskara Festival Celebration, to wit:



a) LACSON STREET PARTY

- **October 19 from 1:00 A.M. to 5:00 P.M. of October 20** – partial road closure (except for the stage in 22nd St. which will be full closed from 1:00 A.M. of October 20 to 5:00 A.M. of October 24)
- **October 20 from 6 P.M. to 5 A.M. of October 22** – full road closure except for the stage in 22nd St. which will be full closed from 1 A.M. of October 20 to 5 A.M. of October 24)
- **October 22 from 3 P.M. to 5 A.M. of October 23** – full road closure except for the sage in 22nd St. which will be full closed from 1 A.M. of October 20 to 5 A.M. of October 24)
- **October 23 from 3 P.M. to 5 A.M. of October 24** – full road closure except for the stage in 22nd St. which will be full closed from 1 A.M. of October 20 to 5 A.M. of October 24);
- **South Capitol Road – 1 A.M. of October 19 to 5 P.M. of October 20** – partial road closure;
- **South Capitol Road – 6 P.M. of October 20 to 5 A.M. of October 22** – full road closure;
- **South Capitol Road – 3 P.M. of October 22 to 5 A.M. of October 23** – full road closure;
- **South Capitol Road – 3 P.M. of October 23 to 5 A.M. of October 24** – full road closure;
- **North Capitol Road – 1 A.M. of October 22 to 5 A.M. of October 24** – full road closure;

b) PLAZA FOOD FEST AND CONCERT

- **Gatuslao Street from 4 P.M. of September 30 to 6 A.M. of October 24** (regular operations every 6 A.M. to 3 P.M.)
- **Gonzaga Street from 11 P.M. of September 30 to 6 A.M. to October 24** (regular operations every 6 A.M. to 3 P.M.)
- **San Juan Street from 11 P.M. of September 30 to 6:00 A.M. of October 24** (regular operations every 6 A.M. to 3 P.M.)
- **Rizal Street from 11 P.M. of September 30 to 6 A.M. of October 24** (regular operations every 6 A.M. to 3 P.M.)



c) BCGC FOOD FEST AND CONCERT

- **Entrance and Exit Road of BCGC – 11:00 P.M. of September 30, to 6:00 A.M. of October 24** - no road closure vehicles pass in one lane in the middle)
- Roads and parking in the front and rear of the BCGC Grounds from 11:00 P.M. of September 30 to 6:00 A.M. of October 24
- All alternate roads in the BCGC grounds from 11:00 P.M. of September 30 to 6:00 A.M. of October 24.

D) THE UPPER EAST, MEGAWORLD

- **Full road closure at the right lane of the Upper East Strip facing Lopez-Jaena Street from 11:00 P.M. of September 30 to 6:00 A.M. of October 24**
- **Full road closure at the left lane of the Upper East Strip facing Lopez-Jaena Street from 11:00 P.M. of October 14 to 2:00 P.M. of October 15.**
