CITY ORDINANCE NO. 630
January 16, 2013

AN ORDINANCE EXTENDING THE DEADLINE OF A ONE STOP SHOP PROGRAM OF THE CITY FROM JANUARY 15 TO FEBRUARY 15, 2013 IN ORDER TO ACCOMMODATE ALL TAXPAYERS WHO WOULD WANT TO AVAIL OF THE PRIVILEGES ESPECIALLY ON THE AMENDMENTS OF THE REVISED REVENUE CODE, PER LETTER-REQUEST FROM THE HONORABLE CITY MAYOR EVELIO R. LEONARDIA DATED JANUARY 11, 2013, DOCKETED AS SP CORRESPONDENCE NO. 013-49.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 – The deadline of One Stop Shop Program of the City is hereby extended from January 15 to February 15, 2013 in order to accommodate all taxpayers who would want to avail of the privileges especially on the amendments of the Revised Revenue Code, per letter-request from the Honorable City Mayor Evelio R. Leonardia dated January 11, 2013, docketed as SP Correspondence No. 013-49.

Section 2 – This ordinance shall take effect upon its approval.


