**AN ORDINANCE GRANTING TWENTY PERCENT (20%) DISCOUNT TO STALL AWARDEES OR LESSEES WHO ARE FAITHFULLY PAYING THEIR MONTHLY BLOCK RENTALS FOR ONE (1) YEAR IN RELATION TO THE EXTENSION GRANTED UNDER ARTICLE 11 OF CITY ORDINANCE NO. 407, SERIES OF 2006 AND CITY ORDINANCE NO. 583, SERIES OF 2012.**

**Section 2.** - This ordinance shall take effect upon its approval






**ENDORSEMENT**
