CITY ORDINANCE NO. 639
April 10, 2013

AN ORDINANCE AUTHORIZING THE CITY COOPERATIVE AND LIVELIHOOD DEVELOPMENT OFFICE (CCLDO) TO COLLECT FEES IN THEIR PRODUCT MARKETING CENTER OR SHOWROOM, TRADE FAIRS AND OTHER MARKETING VENUE PROVIDED FOR THEIR CLIENTS, PROFESSIONAL FEES FOR THE CONDUCT OF TRAININGS/SEMINARS, BUSINESS/PROJECT CONSULTANCY AND MANAGEMENT, PROPERTY/SPACE RENTAL, EQUIPMENTS, FACILITIES AND OTHER SOCIO-ECONOMIC ENTERPRISE ACTIVITY OF THE OFFICE AND FOR OTHER PURPOSES.

BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF BACOLOD, IN SESSION ASSEMBLED, that:

Section 1 – Title – This ordinance shall be known as:

CITY COOPERATIVE AND LIVELIHOOD DEVELOPMENT OFFICE (CCLDO) FEES ORDINANCE.

Section 2 – Definition of Terms

Carton Sealing Machine – machine used to seal cartons by the use of packaging tape.

Cup Sealing Machine – machine used to seal cups by a plastic material.

Economic Enterprise – a profit making business undertaking or project.

Electronic Library – a computer unit with installed software used to access livelihood programs.

Professional Fee – a fee being paid to a person engaged in a specified occupation or expertise.

PH Meter – instrument use to analyze the acidity of food and food products.

Refractometer – instrument use to measure the ratio of soluble solid-sucrose.

Product Marketing Center/Showroom – a room used to display goods and wares that are for sale. Located at Luzuriaga Street, GF-City Hall Building.



Shrink Packaging Machine – machine used to pack a product by enclosing it in transparent plastic film that shrinks tightly.

Vacuum Packaging Machine – machine used to pack a product that removes air from the package prior to sealing. A method of packaging used to extend shelf life of foods or products.

Section 3. Imposition of Fees. There is hereby levied a corresponding fees to be collected for the services rendered by the City Cooperative and Livelihood Development Office.

Section 4. Fees, Rental and Other Charges.

- 1) Space Rental Fee. Resident of Bacolod City ----- 15% of Gross Sales
For outside resident of Bacolod City (shelves only at the showroom)
 - A. Small ----- P 1,000.00
 - B. Large ----- P 2,000.00
- 2) Professional Fee (conduct of an advanced and specialized trainings on cooperative, entrepreneurship, skills trainings and technology resource training) per day ----- P 2,000.00
 - A. Resource Speaker/Trainer Share 80%
 - B. City of Bacolod/CCLD share 20%
- 3) Electronic Library (usage per hour) ----- P 20.00
- 4) Livelihood Information Manuals (photo copy fees)
 - A. Short size ----- P 2.00
 - B. Long size ----- P 2.50
- 5) CD/DVD of Training Program (mark-up rate on the original Acquisition cost acquired from Technology Resource Center/TRC/DOST) 20%

6) Rent of Equipment:

A. TV with VHS (per hour) -----	P	100.00
B. Digital Projector (per hour) -----	P	200.00
C. Digital Projector with pull down screen (per hour) ----	P	250.00
D. Digital Projector with desktop computer and Pull-down screen (per hour) -----	P	300.00

Section 5. Time and Place of payment. Upon issuance of the order of payment by the CCLDO or his duly authorized representative, the fees imposed shall be paid to the City Treasurer.

Section 6. Disposition of Fees Collected. All fees collected under this Ordinance shall be deposited as follows:

- 6.1. Thirty Percent (30%) will go to the General Fund of the City.
- 6.2. Seventy Percent (70%) will be deposited separately to any government banking institution as Trust Fund for the operations, maintenance and other operating expenses of the Product Marketing Center/Showroom of the City Cooperative and Livelihood Development Office (CCLDO) and can be utilized for the purchase of equipments.

In order to avail of such fund the CCLDO must prepare a program of work which must be approved by the City Mayor and shall follow the procedure of its procurement, release and utilizations of funds in pursuance to COA Circular No. 2007-01, dated October 25, 2007.

Section 7. Separability Clause. If for any reason, any provision, section, or part of this Ordinance is declared not valid by a court of competent jurisdiction, such judgment shall not affect or impair the remaining provisions, sections, or parts which shall continue to be in force and effect.

Section 8. Applicability Clause. All other matters relating to the impositions in this Ordinance shall be governed by pertinent provisions of existing laws and other ordinances.

Section 9. Repealing Clause. Any ordinance, memorandum, order, rule or regulation or provisions thereof inconsistent with the provisions of this ordinance are hereby repealed, amended or modified accordingly.

Section 10. Effectivity Clause. This ordinance shall take effect Fifteen (15) days after its approval and following its publication in a newspaper of general circulation in the City of Bacolod.




