CITY ORDINANCE NO. 08-13-654
September 25, 2013

AN ORDINANCE CREATING 30 POSITIONS OF LOCAL LEGISLATIVE STAFF OFFICER I, GRADE 11/STEP 1 AND 15 POSITIONS OF LOCAL LEGISLATIVE STAFF OFFICER II, GRADE 13/STEP 1 IN THE OFFICE OF THE SANGGUNIANG PANLUNGSOD.

WHEREAS, at present, each Councilor and Vice Mayor is provided with three (3) Technical Staff as their assistants in performing their mandated tasks;

WHEREAS, Memorandum Circular No. 22, series of 2007 issued by the Civil Service Commission (CSC), allows employees whose function are confidential in nature, such as Technical Staff/Assistants in the Sangguniang Panlungsod under the Councilors and Vice Mayor to the following positions:

1) LOCAL LEGISLATIVE STAFF OFFICER I, GRADE 11/STEP 1

and

2) LOCAL LEGISLATIVE STAFF OFFICER II, GRADE 13/STEP 1

WHEREAS, the above-stated positions are confidential in nature and are co-terminus with the City Councilors & Vice Mayor of Bacolod City.

NOW THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED by the Sangguniang Panlungsod of Bacolod City in session, assembled that:

Section 1. Creation. There is hereby a created,

- a) Thirty (30) Positions of Local Legislative Officer I, Grade 11/Step 1, and
- b) Fifteen (15) Positions of Local Legislative Officer II, Grade 13/Step 1

Section 2. Source of Fund. The source of fund shall be taken from the General Fund of the city and shall be included in the annual budget.

Section 3. Repealing Clause. Upon implementation of this ordinance, the Ordinance No. 226, series of 1999 (An ordinance creating the position of Local Legislative Employee II, Grade 11/Step 1 in the Office of the Sangguniang Panlungsod of Bacolod City) is hereby repealed accordingly.

Section 4. Effectivity – This ordinance shall take effect immediately upon its approval. *J*


