CITY ORDINANCE NO. 08-13-659

November 6, 2013

**AN ORDINANCE AMENDING SECTION 5 OF CITY ORDINANCE NO. 505 OTHERWISE KNOWN AS "AN ORDINANCE ESTABLISHING THE HIGHLY URBANIZED CITY AGRICULTURAL AND FISHERY COUNCIL (HUCAFC)", AS AMENDED BY CITY ORDINANCE 581, SERIES OF 2012.**


**WHEREAS**, the effective implementation of the program and project of the City's agricultural and fisheries sectors will be of great help to the lives of every Bacofeños, most specifically to better enhance the considered sector for the promotion and preservation of the "last bastion or frontier of our economy";

**WHEREAS**, the need to increase the funding allocation for the Agricultural and Fisheries Sectors and the duly established HUCAFC, is very essential to meet the demands of the entire agricultural and fisheries sectors in the City of Bacolod, and in subscription to the national agricultural agenda.

**NOW THEREFORE**, BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF BACOLOD CITY, in session assembled, that:

**Section 5. FUNDING ALLOCATION** – For the purpose of ensuring the successful implementation of the city's agricultural and fisheries program and projects through the facilitation of sound policy direction, and in subscription to the mandate of the national government, the amount of TWO MILLION PESOS (Php2,000,000.00) shall be appropriated to the HUCAFC for every fiscal year.

The amount shall be utilized exclusively by the HUCAFC for their expenses, but not limited to the following:

- 
- a. Agricultural and Fisheries Supplies;
  - b. Agricultural and Fisheries Equipment;
  - c. Office Supplies;
  - d. Training Expenses;
  - e. Other Operating Expenses; and
  - f. Other Professional Expenses



The amount to be appropriated by the City to HUCAFIC shall be subject to submission of the appropriate program of works and detailed action plan to be prepared by the Head of the City Department of Agriculture as proposed by the HUCAFIC and recommended for approval by the SP Chairman of the Committee on Agriculture and Fisheries to the Office of the City Mayor.

The proper accounting and auditing procedures shall be applied in the fund disbursement intended for HUCAFIC.

**5.1 HONORARIA OF ALL HUCAFIC OFFICERS.** – All officers duly elected by the HUCAFIC shall receive a reasonable honorarium to be taken from the annual budget appropriated to the HUCAFIC by the City of Bacolod.

To avail of the honoraria, there must be a monthly meeting and a record of attendance must be attached by an officer claiming the same and must be duly attested and certified by the Chairman or in the absence of the Chairman, the Vice Chairman of the HUCAFIC. Records of the Minutes of the monthly meeting and its supporting documents on attendance and availment of honoraria may be submitted to the City Mayor's Office if so required.






