**CITY ORDINANCE NO. 08-15-713
January 21, 2015**

AN ORDINANCE GRANTING ADDITIONAL INCREASE IN FINANCIAL ASSISTANCE IN THE AMOUNT OF FIVE HUNDRED PESOS (Php 500) PER QUARTER TO MEMBERS OF THE BACOLOD CITY VETERANS OF WORLD WAR II OR THEIR SURVIVING SPOUSES AND PROVIDING FUNDS THEREFOR.

WHEREAS, the City has a budget of Two Million Five Hundred Thousand Pesos (Php 2,500,000.00) from the City Mayor's Office for its Veterans Welfare Program facilitated by the City Social Services and Development Office given as financial assistance to six hundred thirty-seven (637) members of the Bacolod City Veterans of World War II or their surviving spouses;

WHEREAS, the City has been extending financial assistance to members of the Bacolod City Veterans of World War II or their surviving spouses in the amount of One Thousand (Php 1,000.00) per quarter pursuant to City Ordinance No. 503, dated August 14, 2009;

WHEREAS, the decreasing number of Bacolod City Veterans of World War II and their surviving spouses has reduced recipients entitled to receive from said budget, leaving a substantial amount available for its members who are still alive;

NOW THEREFORE BE IT ORDAINED, by the Sangguniang Panlungsod of Bacolod City that:

Section 1. TITLE. This Ordinance shall be known as the "ADDITIONAL FINANCIAL ASSISTANCE TO BACOLOD CITY VETERANS OF WORLD WAR II";

Section 2. DECLARATION OF POLICY. It shall be the declared policy of the City Government of Bacolod City to honor and pay tribute to its Veterans by extending them additional financial assistance and increasing their quarterly allowance or that of their surviving spouse;

Section 3. ADDITIONAL FINANCIAL ASSISTANCE. An additional Financial Assistance in the amount of Five Hundred Pesos (Php 500) shall be given to all surviving Bacolod City Veterans of World War II or their surviving spouses, over



and above the original assistance, which assistance will now be in the total amount of One Thousand Five Hundred Pesos (Php 1,500.00) per quarter;

Section 4. AUTHORITY. A beneficiary under this Ordinance by reason of physical disability or medical condition, may issue, in favor of any third party, an Authorization/ Special Power of Attorney (SPA), to receive said benefit, provided that the said Authority or SPA is confirmed by the concerned Post Commander;

Section 5. SOURCE OF FUNDS. The amount to be given as additional assistance shall be taken from, Financial Assistance, City Mayor's Office to be facilitated by the City's Social Services and Development Office (DSSD);

Section 6. SEPARABILITY CLAUSE. If for any reason, a provision of this Ordinance is declared invalid, the other part or provision hereof not affected, thereby shall continue to be in full force and effect;

Section 7. EFFECTIVITY. This Ordinance shall take effect immediately upon its approval.
