
WHEREAS, Section 2 of City Ordinance 650 authorizes the Sangguniang Panlungsod to altogether strip the authority to recommend by the officials of the recognized association and assign it to some other persons, when it is used in abuse of authority or discretion;

WHEREAS, in the interest of fair play, GRAVARSTODA's status as a recognized association under the Ordinance is revoked as a form of sanction for its repeated refusal to implement Section 1, Subsection 14.a of City Ordinance 650 and such status is granted to ARVISTODA as a recognized association with the power to recommend its members who will be issued the franchise to operate;

WHEREAS, GRAVARSTODA's forty five (45) members will still have the privilege of operating motorized tricycles for hire under the Association of Motorized Tricycle Operators and Drivers, Inc. – Granada (AMTODI-G) under Section 1, Subsection 14.a of City Ordinance 650.

NOW THEREFORE, BE IT ENACTED, AS IT IS HEREBY ENACTED BY THE SANGGUNIANG PANLUNGSOD OF BACOLOD CITY BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, IN SESSION ASSEMBLED, that:

Section 1. Short Title. This ordinance shall be known as an Ordinance amending Subsections 14 paragraph e, Subsection 14.a, and Subsection 14 paragraph d of Section 1 of City Ordinance 650, series of 2013, subject to a colatilla, to wit:

1. That an oversight committee be formed composed of the Bacolod Traffic Authority Office (BTAO), the Philippine National Police (PNP), the Committee on Transportation of the Sangguniang Panlungsod and the two Punong Barangays of Barangays Vista Alegre and Granada, within a period of three (3) months and should the same prove to be inadequate or contrary to reality, the same be returned to the Sangguniang Panlungsod for particular adjustments or review.

Section 2. Subsection 14 paragraph e of City Ordinance 650, series of 2013, as amended, will now read as:

No. of Units	: 30
Terminal	: Corner Bangga Bagol and Burgos Extension (Granada Road);
Route	: From Terminal to Granada, Progreso Village and neighboring haciendas and Granada Elementary School and High School, and San Dionisio Subd.;
Association	: Arao-Vista Alegre Tricycle Operators and Drivers Association (ARVISTODA)

Section 3. Subsection 14.a of City Ordinance 650, series of 2013. (deleted)

No. of Units : 75
Terminal : San Dionisio Subdivision and 2nd Road
Route : From Terminal to any point of San Dionisio Subd. to Granada Proper;
Association : Association of Motorized Tricycle Operators and Drivers in Brgy. Granada (AMTODI-G)


Section 5. Effectivity. This Ordinance shall take effect immediately upon its approval.


