CITY ORDINANCE NO. 08-15-726
April 8, 2015

AN ORDINANCE AMENDING SECTIONS 9, 14 AND 18 OF CITY ORDINANCE NO. 527, SERIES OF 2010, 'AN ORDINANCE ESTABLISHING THE BACOLOD CITY LYING-IN AND BIRTHING HOME CENTER.

WHEREAS, among the landmark legislations passed by the Sangguniang Panlungsod, which is proven to be more beneficial for the people of Bacolod is the City Ordinance No. 527, series of 2010, "An Ordinance Establishing the Bacolod City Lying-in and Birthing Home Center";

WHEREAS, through the years of its effectiveness, nonetheless, to attune with the times, and to be more responsive to the needs of the people, the same City Ordinance needs modification.

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Panlungsod of Bacolod City in session assembled, that:

Section 1. Section 9 of City Ordinance No. 527, series of 2010 is hereby amended, to read as follows, to wit:

Section 9. Service Fees

FOR NON-PHILHEALTH MEMBERS:

TYPE OF PATIENT	DELIVERY FEES	NEW-BORN SCREENING
Resident of Bacolod City	Php 1,400.00	Php 600.00
Non-Resident of Bacolod City	Php 2,200.00	Php 600.00

Section 2. Sub-Paragraph 14.1 of Section 14 thereof is hereby amended to read as follows, to wit:

14.1 The Bacolod City Lying-in Clinic and Birthing Home Center shall operate in THREE (3) SHIFTS based on the following schedules:

- 1) First Shift - from 6:00 A.M. to 2:00 P.M.
- 2) Second Shift - from 2:00 P.M. to 10:00 P.M.
- 3) Third Shift - from 10:00 P.M. to 6:00 A.M.

Section 3. Sub-Paragraph 18.3.2 of Section 18 thereof is hereby amended to read as follows, to wit:

18.3.2 Necessary equipment, ambulance and other service vehicles, building construction/renovation or expansion for sustainable improvement of services and continued development of the Lying-in Clinic and Birthing Home Center.

Section 4. Separability Clause – If any provision of this ordinance is held invalid, provisions which are not affected shall remain in full force and effect.

Section 5. Effectivity Clause – This ordinance shall take effect after fifteen (15) days after publication in the local newspaper of local circulation.
