CITY ORDINANCE NO. 08-15-733 May 13, 2015

AN ORDINANCE AMENDING SECTION VIII OF CITY ORDINANCE NO. 528, SERIES OF 2010, KNOWN AS AN ORDINANCE CREATING A PRE-MARRIAGE COUNSELING TEAM IN THE CITY OF BACOLOD AND PROVIDING FUNDS THEREOF.

WHEREAS, it is the policy of the City Government of Bacolod to sustain and improve delivery of its various programs and services for its constituents;

WHEREAS, after almost five (5) years since the passage and implementation of C. O. 528, Series of 2010, otherwise known as 'An Ordinance Creating a Pre-Marriage Counseling Team in the City of Bacolod and Providing Funds Thereof, higher demands for more efficient services to meet fast-changing technological advancements on trainings, workshops and orientations conducted during regular sessions and for special exclusive sessions, call for some amendments in the afore-stated Ordinance.

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Panlungsod of Bacolod City, in regular session assembled:

Section I. That Section VIII of C. O. 528 Series of 2010, to wit:

Section VIII. FEE

There shall be a fee of One Hundred Fifty Pesos (P150.00) for every Pre-Marriage Counseling to be conducted by the Team. The Pre-marriage Counseling fees shall be deposited directly to the General Fund and exclusively to be used for the enhancement and improvement of the Pre-Marriage Counseling facilities, supplies and equipments needed by the Team.

In the case where a request for a special Pre-Marriage Counseling be conducted by the Team outside of their official schedules and venue, a fee of Two Thousand Pesos (P2.000.00) shall be charged on the requesting couple.

Section II. Effectivity. This amendatory ordinance shall take effect fifteen (15) days after its publication in a newspaper of general circulation in the City of Bacolod.
