**CITY ORDINANCE NO. 08-15-741
May 27, 2015**

AN ORDINANCE ESTABLISHING GUIDELINES IN SHARING PROFESSIONAL FEES COMPONENT UNDER PHILHEALTH MATERNITY CARE PACKAGE (MCP) IN THE BACOLOD CITY LYING-IN CLINIC AND BIRTHING HOME CENTER.

WHEREAS, Republic Act No. 7160 or Local Government Code of 1991 states – “Every LGU shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”;

WHEREAS, Section 36. [under the provision on the Role of the Local Government Units (LGUs)] of Republic Act No. 7875, otherwise known as, “the National Health Insurance Act of 1995, as amended, and for other purposes”, states – “consistent with the mandates for its political subdivision, LGUs shall provide health services, and to augment their funds it shall invest the capitation payments given to them by the Corporation on health infrastructures or equipment, professional fees Provided the basic health services shall be ensured, especially with the end in view of improving maternal, infant and child health”;

WHEREAS, PhilHealth Circular No. 25, series of 2003 (Supplement to the rules on PhilHealth maternity care benefits for hospitals and non-hospital facilities), particularly, under subparagraph 4.B (PAYMENT under II. NON-HOSPITAL FACILITIES) states that, “All accredited non-hospital facilities are obliged to give not less than 40% of the case payments to the health care professionals who provided the services to members and dependents”, of which Bacolod City Lying-In Clinic and Birthing Home Center is among such non-hospital facilities accredited by PhilHealth that offered maternity care for pregnant women;


WHEREAS, PhilHealth Circular No. 022, series of 2014 which amended PhilHealth Circular No. 39, Series of 2009, particularly, under the following provisions thereof, state:

VI. BENEFITS PACKAGE FOR WOMEN ABOUT TO BIRTH

A. Maternity Care Package (MCP)

Section 4. Implementing Rules and Regulations (IRR). – The Local Health Board (LHB) shall formulate the Implementing Rules and Regulations of this Ordinance, which shall be submitted to the Sangguniang Panlungsod for ratification within sixty (60) days upon effectivity.

Section 5. Separability Clause. – If any provision of this ordinance is held invalid, provisions which are not affected shall remain in full force and effect.

Section 6. Effectivity Clause. – This ordinance shall take effect after fifteen (15) days after publication in the local newspapers of local circulation.




CERTIFICATION
