AN ORDINANCE AMENDING SECTION III OF CITY ORDINANCE NO. 290, SERIES OF 2001, KNOWN AS "AN ORDINANCE ESTABLISHING SERVICE FEE FOR LABORATORY AND ANCILLARY SERVICES.

**WHEREAS**, the Sangguniang Panlungsod of Bacolod City has already approve City Ordinance No. 290, series of 2001;

**WHEREAS**, Section III did not include Circumcision Fees that is necessary for the Operation Tuli Section in the City Health Office to operate continuously.

**Section 2. EFFECTIVITY CLAUSE.** This Ordinance shall take effect fifteen (15) days after its publication in any newspaper of general circulation within the city.
