CITY ORDINANCE NO. 844
March 26, 2018

AN ORDINANCE FURTHER AMENDING CITY ORDINANCE NO. 361, SERIES OF 2004, KNOWN AS "AN ORDINANCE AMENDING CERTAIN SECTIONS OF CITY ORDINANCE NO. 290, SERIES OF 2001, KNOWN AS "AN ORDINANCE ESTABLISHING SERVICE FEE FOR LABORATORY AND ANCILLARY SERVICES.

WHEREAS, the Sangguniang Panlungsod of Bacolod City has already approved City Ordinance No. 361, series of 2004;

WHEREAS, the Local Health Board of Bacolod passed Resolution No. 01-18-23 which proposes the increase of certain fees operated in the Bacolod City Health Office;

WHEREAS, it is necessary to increase such laboratory fees in order for the office to continuously operate;

NOW THEREFORE, BE IT ORDAINED as it is **ORDAINED** by the Sangguniang Panlungsod in session assembled, that:

Section 1. Section 2 of City Ordinance No. 361, series of 2004, which reads:

Section 2. There shall be added fees for the following Dental Fees to be designated as Article No. 14, in Section III of City Ordinance No. 290, series of 2001, to read as follows, to wit:

14. Dental Fees

A) Oral Prophyaxis	Php 150.00
B) Sealant Application	75.00
C) Temporary Filling	80.00
D) Amalgam Filling	150.00
E) Dental Extraction	85.00

shall be amended to read as:

14. Dental Fees

A) Oral Prophyaxis	Php 150.00
B) Sealant Application	75.00
C) Temporary Filling	80.00
D) Amalgam Filling	150.00
E) Dental Extraction	150.00


Section 3. EFFECTIVITY CLAUSE. This Ordinance shall take effect fifteen (15) days after its publication in any newspaper of general circulation within the city.
