**CITY ORDINANCE NO. 845
March 26, 2018**

AN ORDINANCE AMENDING SECTION 9 OF CITY ORDINANCE NO. 527, SERIES OF 2010, KNOWN AS "AN ORDINANCE ESTABLISHING THE BACOLOD CITY LYING-IN AND BIRTHING HOME CENTER.

WHEREAS, the Sangguniang Panlungsod of Bacolod City has already approved City Ordinance No. 527, series of 2010;

WHEREAS, the Local Health Board of Bacolod City passed Resolution No. 01-18-23 which proposes the increase of the rates in the Lying-In and Birthing Home Center in Bacolod City;

WHEREAS, it is necessary to increase such rates to further improve the services of the said center.

NOW THEREFORE, BE IT ORDAINED as it is hereby **ORDAINED** by the Sangguniang Panlungsod in session assembled, that:

Section 1. Section 9 of City Ordinance No. 527, series of 2010 which reads:

Section 9. Service Fees – The patient of the City's Lying-In and Birthing Home Center shall pay for the services rendered as follows:

NON-HOLDERS OF PHILHEALTH CARD (NON-MEMBERS)

| TYPE OF PATIENT | DELIVERY FEES |
|-----------------|---------------|
| RESIDENT | PHP 1,200 |
| NON-RESIDENT | PHP2,000 |

For service offered at the Lying-In and Birthing Home Center the fees to be charged to non-holders of PhilHealth Card will be in accordance with the above-cited rate for all normal deliveries. Five Hundred Pesos (PHP500.00) of which will be charged to the student nurses subject to certain rules and requirements set forth by the City.

All Service Fees shall be exclusive of the new born screening and other charges that may be imposed upon by the Department of Health.

Section 2. EFFECTIVITY CLAUSE. This Ordinance shall take effect fifteen (15) days after its publication in any newspaper of general circulation within the city.




