CITY ORDINANCE NO. 887
March 20, 2019

AN ORDINANCE AMENDING SECTION 6 OF CITY ORDINANCE NO. 847, SERIES OF 2018 OTHERWISE KNOWN AS "AN ORDINANCE AMENDING SECTIONS 1, 2(a) AND (b), 2.a, 3 AND 5 OF CITY ORDINANCE NO. 482, SERIES OF 2009, OTHERWISE KNOWN AS "AN ORDINANCE ESTABLISHING A YEARLY FESTIVITIES TO BE KNOWN AS THE MANOKAN COUNTRY INASAL FESTIVAL IN THE CITY OF BACOLOD INCORPORATING A SPECIAL COMMITTEE TO BE CREATED AND PROVIDING FUNDS FOR ITS IMPLEMENTATION.

WHEREAS, City Ordinance No. 847, Series of 2018 entitled "AN ORDINANCE AMENDING SECTIONS 1, 2 (a) and (b), 2.a, 3 AND 5 OF CITY ORDINANCE NO. 482, SERIES OF 2009 OTHERWISE KNOWN AS "AN ORDINANCE ESTABLISHING A YEARLY FESTIVITIES TO BE KNOWN AS THE MANOKAN COUNTRY INASAL FESTIVAL IN THE CITY OF BACOLOD INCORPORATING A SPECIAL COMMITTEE TO BE CREATED AND PROVIDING FUNDS FOR ITS IMPLEMENTATION" was passed on April 4, 2018 for the purpose of staging a yearly Inasal Festival in the City of Bacolod and to promote the chicken inasal industry of the city;

WHEREAS, at least 3,000 revelers joined in the first Bacolod Chicken Inasal Festival in the City of Bacolod which was held last May 5, 2018;

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Panlungsod of Bacolod City, in session assembled that:

Section 1. Section 6 of the City Ordinance No. 847, Series of 2018, which reads:

"Section 6. ANNUAL CELEBRATION. The City of Bacolod shall celebrate the Bacolod Chicken Inasal Festival every first week of May".

Shall be amended to read as:

The City of Bacolod shall celebrate the Bacolod Chicken Inasal Festival every 4th weekend of May".

Section 2. EFFECTIVITY CLAUSE. This Ordinance shall take effect immediately upon approval.




