CITY ORDINANCE NO. 896  
May 15, 2019

AN ORDINANCE AMENDING SECTION 1 OF CITY ORDINANCE NO. 845, SERIES OF 2018, KNOWN AS "AN ORDINANCE AMENDING SECTION 9 OF CITY ORDINANCE NO. 527, SERIES OF 2018, KNOWN AS 'AN ORDINANCE AMENDING SECTION 9 OF CITY ORDINANCE NO. 527, SERIES OF 2010, KNOWN AS "AN ORDINANCE ESTABLISHING THE BACOLOD CITY LYING-IN AND BIRTHING HOME CENTER' ".

**WHEREAS**, the Sangguniang Panlungsod of Bacolod City has already approved City Ordinance No. 845, Series of 2018;

**WHEREAS**, after a year of testing the fee stated under the ordinance, it has been realized by the City Health Office that the same is not enough to maintain the operation of the center;

**WHEREAS**, the Local Health Board of Bacolod City passed Resolution No. 01-18-23 which proposes the increase of the rate in the Lying-In and Birthing Home Center in Bacolod City;

**WHEREAS**, it is necessary to increase such rates to further improve the services of the said center;

**NOW THEREFORE**, be it ordained as it is hereby ordained by the Sangguniang Panlungsod in session assembled, that:

**SECTION 1.** Section 1 of the City Ordinance No. 845, Series of 2018, which reads:

*Section 9 – Service Fess - The patient of the City's Lying-In and Birthing Home Center shall pay for the services rendered as follows:*

**NON-HOLDERS OF PHILHEALTH CARD (NON-MEMBERS)**

TYPE OF PATIENT	DELIVERY FEES
RESIDENT	PHP 1,200
NON-RESIDENT	PHP 2,400

For service offered at the Lying-In and Birthing Home Center the fees to be charged to Non-holders of PhilHealth Card will be in accordance with the above-cited rate for all normal deliveries. Five Hundred Pesos (PHP 500.00) of which will be charged to the student nurses subject to certain rules and requirements set forth by the City.

All Service Fees shall be exclusive of the new born screening and other charges that may be imposed upon by the Department of Health.

For service offered at the Lying-In and Birthing Home Center the fees to be charged to non-holders of PhilHealth Card will be in accordance with the above-cited rate for all normal deliveries. Five Hundred Pesos (PHP 500.00) of which will be charged to the student nurses subject to certain rules and requirements set forth by the City.

All Service Fees shall be exclusive of the new born screening and other charges that may be imposed upon by the Department of Health.

Patients must bring a valid Identification Card with picture when admitted and availing the services of the Lying-In Center.

**SECTION 2. REPEALING CLAUSE.** All previous ordinances inconsistent with this ordinance shall be deemed repealed or modified accordingly

**SECTION 3. EFFECTIVITY CLAUSE:** This Ordinance shall take effect fifteen (15) days after its publication in any newspaper of general circulation within the city.
