CITY ORDINANCE NO. 897

AN ORDINANCE AMENDING SECTION III OF CITY ORDINANCE NO. 290, SERIES OF 2001, KNOWN AS "AN ORDINANCE ESTABLISHING SERVICE FEE FOR LABORATORY AND ANCILLARY SERVICES".

**WHEREAS**, the Sangguniang Panlungsod of Bacolod City has already approved City Ordinance No. 290, Series of 2001;

**WHEREAS**, Section III did not include HbA1c Test Fees that is necessary for the Laboratory of the City Health Office to operate continuously;

**NOW THEREFORE**, be it ordained as it is hereby ordained by the Sangguniang Panlungsod in session assembled, that:

**SECTION 1.** There shall be added fees for the following HbA1c Test Fee to be included as Item No. 16, in Section III of City Ordinance No. 290, Series of 2001, to read as follows, to wit:

16. HbA1c Test

Php 700.00

**SECTION 2. EFFECTIVITY CLAUSE:** This Ordinance shall take effect fifteen (15) days after its publication in any newspaper of general circulation within the city.



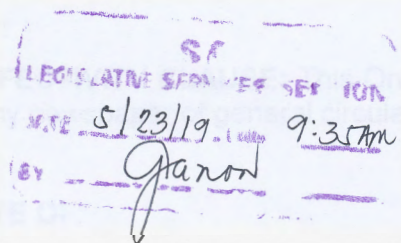
