CITY ORDINANCE NO. 09-17-806
January 25, 2017

AN ORDINANCE AMENDING SECTION 4 OF CITY ORDINANCE NO. 623, SERIES OF 2012 ENTITLED, "AN ORDINANCE INCREASING THE ALLOWANCE OF THE BARANGAY HEALTH WORKERS (BHWS) IN THE CITY OF BACOLOD".

WHEREAS, Barangay Health Workers are the front-liners who provide health care services and programs not only of the city but also of the barangays in order to make sure that the population is healthy;

WHEREAS, the Barangay Health Worker's current allowance is not sufficient to cover their transportation expenses incurred in the performance of their duties and responsibilities, and while transacting with the different government offices, as well as to cushion the increases in the prices of basic commodities, and all other expenses incurred in the exercise of their duties and responsibilities.

NOW THEREFORE, be it enacted by the Sangguniang Panlungsod in session assembled, that:

Section 1. Section 4 of City Ordinance No. 623, Series of 2012, which reads:

"Section 4. Increase of Allowance and incentives. - The City shall allocate funds for the increase of monthly allowance of the Barangay Health Workers from Php2,000.00 to Php3,500.00".

Shall be amended to read as:

The Barangay Health Workers of Bacolod City shall receive a monthly allowance of Php4,000.00.

Section 2. EFFECTIVITY CLAUSE. - This ordinance shall take effect immediately upon approval.




