**CITY ORDINANCE NO. 09-17-807
January 25, 2017**

AN ORDINANCE AMENDING SECTION 10 OF CITY ORDINANCE NO. 593 OTHERWISE KNOWN AS AN ORDINANCE ESTABLISHING A COMPREHENSIVE SUSTAINABLE DEVELOPMENT PROGRAM FOR SHELTER SERVICES AND POVERTY ALLEVIATION OF INFORMAL SETTLERS IN BACOLOD CITY.

Be it enacted by the Sangguniang Panlungsod of Bacolod City that:

Section 1 – Subject of Amendment. – To be amended in this Ordinance is the following provision of Ordinance No. 593.

Section 10. Special Housing Trust Fund.

"12.1 One percent (1%) of the Real Property Tax (RPT) shall be allocated for urban poor services in government-owned property or in On-Site Development."

Section 2 – The amendment. - The foregoing provision shall be amended to read as follows:

"Section 10. Special Housing Trust Fund.

"12.1 One percent (1%) of the City share in the Real Property Tax (RPT) shall be allocated for urban poor services in government-owned property and in On-Site-Development.

"12.2 A mandatory five percent (5%) from the City share in the Real Property Tax (RPT) for Relocation Site and On-Site Acquisition and Development."

Section 3. Effectivity Clause. – This Ordinance shall take effect fifteen (15) days after publication in newspaper of general circulation in the City of Bacolod.


