**RESOLUTION ADOPTING THE COMMITTEE REPORT SUBMITTED BY COUNCILOR PSYCHE MARIE E. SY, RE: LETTER-COMPLAINT FROM THE REGISTERED PROPERTY OWNERS AND RESIDENTS OF PUROK ENCARNACION, BAKYAS, BARANGAY MANSILINGAN, BACOLOD CITY, AGAINST SILVER DRAGON CONSTRUCTION (SDC) FOR ALLEGEDLY OBSTRUCTING THE NATURAL FLOW OF THE CREEK WITHOUT PROVIDING AN ALTERNATIVE METHOD OF DRAINAGE AND DISCHARGING WATER FROM THE SDC PROPERTY TOWARD THE ADJOINING RESIDENCES THAT RESULTS TO FLOODING IN THEIR AREA, DOCKETED AS SP CORRESPONDENCE NO. 11-22-0256-A.**
