**RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT ENTERED INTO BY AND BETWEEN THE CITY OF BACOLOD, REPRESENTED BY THE HONORABLE CITY MAYOR ALFREDO ABELARDO B. BENITEZ AND THE DEPARTMENT OF HEALTH – WESTERN VISAYAS CENTER FOR HEALTH DEVELOPMENT (DOH-WD CHD), REPRESENTED BY ADRIANO P. SUBA-AN, MD, MPH, MCHM, CESO IV, IN HIS CAPACITY AS DIRECTOR IV, RE: TRANSFER OF FUNDS FROM THE DEPARTMENT OF HEALTH THRU THE HEALTH FACILITIES ENHANCEMENT PROGRAM FOR CY 2022 IN THE AMOUNT OF TWO HUNDRED FIFTY MILLION PESOS (PHP250,000,000.00) TO THE CITY OF BACOLOD, FOR THE ESTABLISHMENT OF BACOLOD CITY GENERAL HOSPITAL, DULY NOTARIZED AND DOCKETED AS SP CORRESPONDENCE NO. 11-22-0126-A.**
