**RESOLUTION RESPECTFULLY URGING PLDT, GLOBE, SMART AND OTHER TELECOMMUNICATIONS COMPANY IN BACOLOD CITY TO DILIGENTLY INSPECT THEIR POSTS AND CABLE LINES IN ANTICIPATION OF THE TYPHOON SEASON AND OTHER NATURAL CALAMITIES.**

Upon motion of Councilor Claudio Jesus Raymundo A. Puentevella, jointly seconded by Councilors Simplicia Z. Distrito and Celia Matea R. Flor, the Sangguniang Panlungsod of Bacolod

**RESOLVED**, to pass the following resolution:

**WHEREAS**, Section 5 of Article II of the 1987 Philippine Constitution provides that the maintenance of peace and order, the protection of life, liberty, and property, and the promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy

**WHEREAS**, Section 16 of Republic Act 7160 otherwise known as the Local Government Code of 1991 mandates that Local Government Units to exercise their power which are essential to the promotion of general welfare of the people;



**WHEREAS**, Local Government Units shall ensure and promote health and safety and preserve the comfort and convenience of their inhabitants;

**WHEREAS**, typhoon and other natural calamities take place in different parts of the Philippines from time to time;

**WHEREAS**, as part of disaster preparedness, there is a need to diligently step up said maintenance checks and clearing operations in anticipation of the typhoon season any natural calamities that might affect Bacolod City;

**WHEREAS**, some post and cables owned and operated by the various telecommunications companies in the City of Bacolod needs repair or replacement due to wear and tear.

**WHEREAS**, this resolution directs all telecommunications company in Bacolod City to conduct monitoring and clearing operations in order to strengthen the disaster preparedness for the protection and promotion of the welfare of the people;


