**RESOLUTION RESPECTFULLY REQUESTING BACOLOD TRAFFIC AUTHORITY OFFICE THROUGH THE OFFICE OF THE CITY MAYOR, THE HONORABLE ALFREDO ABELARDO B. BENITEZ AND THE BACOLOD CITY POLICE OFFICE TO STRICTLY ENFORCE CITY ORDINANCE NO. 832, SERIES OF 2017 OR THE REGULATION OF BACKRIDERS IN MOTORCYCLES IN THE CITY OF BACOLOD.**

Upon motion of Councilor Simplicia Z. Distrito, jointly seconded by Floor Leader Al Victor A. Espino and Councilor Claudio Jesus Raymundo A. Puentevella, the Sangguniang Panlungsod of Bacolod

**RESOLVED**, to pass the following resolution:

**WHEREAS**, City Ordinance No. 832, series of 2017 makes it unlawful for any driver and back rider to ride in tandem on a motorcycle on any day from 9pm to 5am in the City of Bacolod;

**WHEREAS**, the ordinance requires the presentation of Valid identification of the driver and the back rider from 9pm to 5am and if violated, a penalty of a fine of P300 and/or imprisonment for three days will be imposed on the driver and a fine of P200 and/or imprisonment for two days for the back rider;



**WHEREAS**, there is a need to strictly implement the same as a pre-emptive means to curtail proliferation of crimes committed by riding in tandem individuals particularly during night time;

**WHEREAS**, the strict implementation of this ordinance will be timely considering that the City is celebrating the MassKara Festival and so many people are in the City to witness and participate in the activities. Criminals also thrive in these activities and one way for us to avert them from doing unlawful activities is to intensify the enforcement of our motorcycle riders roaming at night;

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED**, to respectfully request Bacolod Traffic Authority Office through the Office of the City Mayor, the Honorable Alfredo Abelardo B. Benitez and the Bacolod City Police Office to strictly enforce City Ordinance No. 832, Series of 2017 or the regulation of backriders in motorcycles in the City of Bacolod.
