**RESOLUTION NO. 873**

**RESOLUTION URGING THE CITY LEGAL OFFICE AND THE CITY HEALTH OFFICE THROUGH THE OFFICE OF THE CITY MAYOR, ALFREDO ABELARDO B. BENITEZ TO STRICTLY IMPLEMENT CITY ORDINANCE NO. 823 OTHERWISE KNOWN AS “AMBULANT FOOD VENDORS ORDINANCE OF BACOLOD CITY”.**

Upon motion of Councilor Em L. Ang, jointly seconded by Councilors Israel P. Salanga, Lady Gles Gonzales-Pallen and Claudio Jesus Raymundo A. Puentevella, the Sangguniang Panlungsod of Bacolod

**RESOLVED**, to pass the following resolution:

**WHEREAS**, Section 16, Article II of the 1987 Philippine Constitution provides that, “The State shall protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature”;

**WHEREAS**, City Ordinance No. 823 prohibits all ambulant food vendors to sell food for public patronage without securing a health card from the Bacolod City Health Office;

**WHEREAS**, Section 4 of the above-mentioned ordinance defined the ambulant food vendors as any person who sells food by use of food carts, food stands or any food containers including but not limited to handheld boxes and baskets and is directly and/or indirectly connected with food preparation, handling and selling of food;

**WHEREAS**, it is being observed that there are numerous food carts, food trucks and food stands that are operating all over the city, especially around the Bacolod City Government Center and close proximities to major BPO sites;

**WHEREAS**, to ensure that proper food handling, sanitation and public health standards are strictly observed by the ambulant food vendors, it is necessary for the City Health Office together with the City Legal Office to conduct an inspection of these food establishments and issue corresponding applicable penalties as necessary;

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED**, to urge the City Legal Office and the City Health Office through the Office of the City Mayor, Alfredo Abelardo B. Benitez to strictly implement City Ordinance No. 823 otherwise known as "Ambulant Food Vendors Ordinance of Bacolod City".


