RESOLUTION REQUESTING THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM), MANILA FOR THE RELEASE OF THE LOCAL GOVERNMENT SUPPORT FUND-FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS (LGSF-FA TO LGUs) IN THE AMOUNT OF TWENTY MILLION PESOS (P20,000,000.00) FOR CONSTRUCTION/IMPROVEMENT AND REHABILITATION OF TOURISM LIGHTS LOCATED IN THE VARIOUS STREETS OF THE CITY AND CONCRETING OF ACCESS ROADS TRAVERSING OLD AIRPORT RUNWAY FROM ROAD AT ST. VINCENT SUBDIVISION TO PALMAS DEL MAR SUBDIVISION, PER LETTER REQUEST OF THE HONORABLE CITY MAYOR ALFREDO ABELARDO B. BENITEZ DATED OCTOBER 10, 2022, DOCKETED AS SP CORRESPONDENCE NO. 11-22-0556.

Upon motion of Floor Leader Al Victor A. Espino, jointly seconded by Councilors Jason Isidro S. Villarosa and Simplicia Z. Distrito, the Sangguniang Panlungsod of Bacolod

RESOLVED, to request the Department of Budget and Management (DBM), Manila for the release of the Local Government Support Fund-Financial Assistance to Local Government Units (LGSF-FA to LGUs) in the amount of Twenty Million Pesos (P20,000,000.00) for construction/improvement and rehabilitation of tourism lights located in the various streets of the city and concreting of access roads traversing old airport runway from road at St. Vincent Subdivision to Palmas Del Mar Subdivision, per letter request of the Honorable City Mayor Alfredo Abelardo B. Benitez dated October 10, 2022, docketed as SP Correspondence No. 11-22-0556.


