RESOLUTION GRANTING THE REQUEST OF FLORAME SANTOS YANG, PRESIDENT, EKXINUM, INC., (DOING BUSINESS UNDER THE NAME AND STYLE OF "OKBET") FOR A RESOLUTION OF NO OBJECTION (RONO) FOR THE ESTABLISHMENT OF THEIR GAMING SITES IN THE CITY OF BACOLOD, DOCKETED AS SP CORRESPONDENCE NO. 11-22-0543, WITH A COLATILLA THAT THE GRANTING OF THE SAME IS NOT OPERATIONAL UNLESS THE SANGGUNIANG PANLUNGSOD IS IN RECEIPT OF A SIGNED COPY MEMORANDUM OF AGREEMENT BETWEEN THE PARTIES "ACES" AND "OKBET."


