RESOLUTION RESPECTFULLY REQUESTING THE HONORABLE BACOLOD CITY MAYOR ALFREDO ABELARDO B. BENITEZ TO STRICTLY IMPLEMENT BACOLOD CITY ORDINANCE NO. 08-15-721, SERIES OF 2015 "AN ORDINANCE STRENGTHENING THE IMPLEMENTATION OF REPUBLIC ACT NO. 10627 OR " AN ACT REQUIRING ALL ELEMENTARY AND SECONDARY SCHOOLS TO ADOPT POLICIES TO PREVENT AND ADDRESS THE ACTS OF BULLYING IN THEIR INSTITUTIONS AND FOR OTHER PURPOSES".

Upon motion of Councilor Claudio Jesus Raymundo A. Puentevella, seconded by Councilor Celia Matea R. Flor, the Sangguniang Panlungsod of Bacolod

RESOLVED, to pass the following resolution:

WHEREAS, Article XIV, Section 3 of the 1987 Philippine Constitution provides that the State shall mandate all educational institutions to develop the moral character and personal discipline of students.;

WHEREAS, Republic Act No. 10627 or the Anti Bullying of 2013 states that all elementary and secondary schools are hereby directed to adopt policies to address the existence of bullying in their respective institutions and the Local Government Units must help in the proper implementation of the law in its educational institutions for the welfare of the students;

WHEREAS, Students who experience bullying are at increased risk for depression, anxiety, sleep difficulties, lower academic achievement, and dropping out of school.

WHEREAS, there is a need to shape the conduct of the students to instill discipline and essential values so as to integrate them to be productive and dynamic citizens of the City;

WHEREAS, as we shift from distant learning to face-to-face classes, schools should include in their policies and practices to educate bullying and harassment among students.

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to respectfully request the Honorable Bacolod City Mayor Alfredo Abelardo B. Benitez to strictly implement Bacolod City Ordinance No. 08-15-721, Series of 2015 "An ordinance strengthening the implementation of Republic Act No. 10627 or "An act requiring all elementary and secondary schools to adopt policies to prevent and address the acts of bullying in their institutions and for other purposes".
