**CITY ORDINANCE NO. 246  
JANUARY 20, 2000**

**AN ORDINANCE GRANTING 99.1 CROSSOVER (DYBM-FM BACOLOD) TO PAY A FIVE PERCENT (5%) AMUSEMENT TAX IN CONNECTION WITH ITS HOLDING OF A CONCERT ENTITLED "MARTIN NIEVERA XVII – THE CROSSOVER LIVE TOUR" ON JANUARY 22, 2000 AT THE UNIVERSITY OF ST. LA SALLE COLISEUM WITH THE BALAYAN VOLUNTEER AND FORMATION OFFICE OF THE UNIVERSITY OF ST. LA SALLE-BACOLOD AND THE HOLY INFANT NURSERY FOUNDATION, INC. AS ITS BENEFICIARIES, PER LETTER OF MS. GRACE K. RAMOS, STATION MANAGER, DATED JANUARY 14, 2000 AND DOCKETED AS SP CORRESPONDENCE NO. Y2-35-A.**

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 – A payment of FIVE PERCENT (5%) amusement tax is hereby granted to 99.1 Crossover (DYBM-FM Bacolod) to pay a FIVE PERCENT (5%) amusement tax in connection with its holding of a concert entitled "MARTIN NIEVERA XVII – THE CROSSOVER LIVE TOUR" on January 22, 2000 at the University of St. La Salle Coliseum with the Balayan Volunteer and Formation Office of the University of St. La Salle-Bacolod and the Holy Infant Nursery Foundation, Inc. as its beneficiaries, per letter of Ms. Grace K. Ramos, Station Manager, dated January 14, 2000 and docketed as SP Correspondence No. Y2-35-A.

Section 2 - This ordinance shall take effect upon its approval.




