CITY ORDINANCE NO. 253
April 27, 2000

AN ORDINANCE CREATING THE POSITION OF ONE (1) STENOGRAPHIC REPORTER II, GRADE 9, STEP 1, UNDER THE STENOGRAPHIC SERVICES SECTION IN THE OFFICE OF THE SANGGUNIANG PANLUNGSOD, BACOLOD CITY, AND APPROPRIATING FUNDS THEREOF.

WHEREAS, at present there is a need to create one (1) position of STENOGRAPHIC REPORTER II, G-9, S-1, under the Stenographic Section in the Office of the Sangguniang Panlungsod, Bacolod City;

WHEREAS, the position title is in accordance with Local Budget Circular No. 61, dated March 18, 1996, the Revised Index of Occupational Services, Positions Title and Salary Grade (6S) in the Local Government;

WHEREAS, the function of said position is to take down the proceedings and transcribes the minutes and other stenographic jobs in the Stenographic Services Section of the Office of the Sangguniang Panlungsod;

WHEREAS, the amount of ONE HUNDRED THIRTY EIGHT THOUSAND FOUR HUNDRED NINETY SEVEN PESOS AND FORTY EIGHT CENTAVOS (P138,497.48) is allocated annually as salaries and wages and other benefits for the said created position.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - That there is hereby created in the Office of the Sangguniang Panlungsod the position of STENOGRAPHIC REPORTER II, Grade 9, Step 1.

Section 2 - That the amount of ONE HUNDRED THIRTY EIGHT THOUSAND FOUR HUNDRED NINETY SEVEN PESOS AND FORTY EIGHT CENTAVOS (P138,497.48) is hereby appropriated annually for the salaries and wages and other benefits for the said position.

Section 3 - This ordinance shall take upon its approval.




