**CITY ORDINANCE NO. 254**

**April 28, 2000**

**AN ORDINANCE APPROVING THE REQUEST OF THE NEGROS SLASHERS, THRU ITS VP-FINANCE, VICENTE G. TAN, TO PAY A FIVE (5%) PERCENT AMUSEMENT TAX ON THEIR GAMES SCHEDULED ON MAY 13, 17, 21 AND 28, 2000 AND ON JUNE 4, 2000 IN BACOLOD CITY WITH THE BANTAY BATA FOUNDATION, NEGROS MUSEUM AND CHAMBER VOLUNTEER FIRE BRIGADE AS THEIR BENEFICIARIES AS CONTAINED IN SP CORRESPONDENCE NO. Y2-284.**

Section 1 - The request of the Negros Slashers, thru its VP-Finance, Vicente G. 


