AN ORDINANCE APPROVING THE REQUEST OF THE NEGROS SLASHERS, INC., THRU MR. VICENTE G. TAN, VP-FINANCE, TO PAY A FIVE (5%) PERCENT AMUSEMENT TAX ON THEIR MBA 2000 INTRA-CONFERENCE GAMES IN BACOLOD CITY SCHEDULED ON JUNE 25 & 28, JULY 1, 9 & 16 AND SEPTEMBER 3, 2000 WITH THE CHAMBER VOLUNTEER FIRE BRIGADE/BACOLOD FILIPINO-CHINESE CHAMBER OF COMMERCE AND INDUSTRY, INC. AND BANTAY BATA FOUNDATION/ABS-CBN FOUNDATION AS THEIR BENEFICIARIES, DOCKETED AS SP CORRESPONDENCE NO. Y2-663.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - The request of the Negros Slashers, Inc., thru Mr. Vicente G. Tan, VP-Finance, to pay a Five (5%) percent amusement tax on their MBA 2000 Intra-Conference Games in Bacolod City scheduled on June 25 & 28, July 1, 9 & 16 and September 3, 2000 is hereby approved with the Chamber Volunteer Fire Brigade/Bacolod Filipino-Chinese Chamber of Commerce and Industry, Inc. and Bantay Bata Foundation/ABS-CBN Foundation as their beneficiaries, docketed as SP Correspondence No. Y2-663.




