



CITY ORDINANCE NO. 257

August 3, 2000

AN ORDINANCE APPROVING THE PAYMENT OF FIVE PERCENT (5%) AMUSEMENT TAX ON THE SHOW "JAYA ON FIRE - THE CROSSOVER LIVE TOUR" WHICH WILL BE HELD ON AUGUST 26, 2000 AT THE UNIVERSITY OF ST. LA SALLE COLISEUM, BACOLOD CITY, WITH THE NEGROS ELDERS FOUNDATION, INC. AND THE BALAYAN, VOLUNTEER FORMATION AND COMMUNITY DEVELOPMENT OFFICE AS ITS BENEFICIARIES, PER LETTER-REQUEST OF MS. GRACE RAMOS, STATION MANAGER, 99.1 CROSSOVER DATED JULY 24, 2000, DOCKETED AS SP CORRESPONDENCE NO. Y2-826.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:




